**Course Description:** Examination of client/server concepts, components, and operations as related to the business environment. This course will provide students with an opportunity to improve research skills, gather data, and synthesize that data toward workable conclusions. The student will complete a real-world project related to his/her employment environment. Statistical analysis concepts and methods will be utilized in data collection and measurement of results. Topics include major business operating system platforms, relational database designs, structured query language, trends in database products and applications, and local and wide area networking technologies utilized in business.
