REQUIREMENTS FOR COMPLETING THE COURSE:

Student must complete all work required by instructor.

TOPICS:

The Sociology of Health and Illness studies how social relations, social structures, human interaction and culture profoundly shape health, illness and medicine. This course examines the sociocultural aspects of health and illness, the patient-practitioner relationship, the socialization of health practitioners, the social organization of health care services, and the role of ethics in medical decision-making. It analyzes the problems and inequalities in the present system of health care delivery in the United States, with particular emphasis on the sexism, racism, and classim in policy and practice. It analyzes alternative models of health care delivery, and discusses modifications in policy and practice necessary to bring about change.

LEARNING OBJECTIVES: Upon completion of this course, the student will be able to:

- 1. Describe how social roles of the sick/healthy and able-bodied/disabled are social-cultural constructions as well as individual biological-physician phenomena.
- 2. Explain how the production and consumption of food contribute to understanding health issues in the U.S., and how economic and political forces shape food production and consumption.
- 3. Describe how environmental conditions and contaminants influence public health, and how social, political, economic, and cultural forces shape environmental conditions and contaminants.
- 4. Explain how social-cultural structures and forces, including socio-ecomonic inequality, racism community cohesion, and social status shape health care outcomes, directly and indirectly.
- 5. Explain how medical personnel are trained-socialized and describe how the professional health care system operates with hospitals, clinics, health care workers and medical support industries.

- 6. Compare and describe traditional-scientific medicine and alternative forms of health care, and explain how social-cultural and political-economic factors affect these health-care methods.
- 7. Descrive the structure and operation of the American health care system, and contrast its major features with the health care systems found in other advanced industrial nations.
- 8. Discuss ethical issues/moral dilemmas involved in conducting medical research, providing or withholding health care for the sick and dying.

Academic Integrity:

Notes on discussion forum's: I do not want generic answers or one/two sentence responses to the discussion posts. To earn full credit you must provide thoughtful and insightful discussion posts. Don't wait until the last minute to post something or base your answer on a standard answer your peers have posted. I want to know you read the material and can explain concepts and theories based on what you read. Moreover, when responding to your peer's post, don't just say "I agree". Give a reason why you agree. Follow it up with a concept in the text or online that you research regarding the discussion.

Grading for Discussion Posts:

5 points – If initial post is posted by Wed of that week 5 points – a thoughtful response to someone else's post Total possible points = 10 points

If you post late (past Wed of that week), you will only receive 2 points for the initial post
